## Brief profile of Dr. GVK Reddy (DIN: 00005212)

Dr. GVK Reddy is the Founder Chairman of "GVK". He holds a Bachelor's Degree in Arts and has completed the Owner/President Management Program from Harvard Business School. He has also been awarded a Doctorate in Philosophy from the Jawaharlal Nehru Technological University. He has been conferred with the "Padma Bhushan" award from the Government of India in the category of Trade and Industry on 25th January, 2011.

He is a first generation industrialist and the founder of the GVK Group which has businesses in the energy, urban infrastructure, transportation, particle boards, hospitality, petrochemicals, biotechnology and finance sectors. His career spanning the last49 years started with his involvement in the construction of major infrastructure projects for the Government such as dams, power houses, irrigation canals, bridges, roads, aqueducts and under tunnels.

The hospitality business of the "GVK" which was initiated as a strategic alliance formed by him with the "Taj" Group, has four hotels in Hyderabad, one each at Chandigarh Chennai and Mumbai. One more hotel is under consideration at Bangalore. He also pioneered the establishment of the 217 MW Jegurupadu combined cycle power plant, India's first independent power producer and the Jaipur-Kishangarh BOT road project, a segment of the Golden Quadrilateral National Highways Development Project of the Gol.

Under his able guidance "GVK" was awarded modernization and up gradation of Chhatrapati Shivaji Maharaj International Airport, Mumbai under international competitive bidding in, 2006. This complex project has made a bench mark international airport in the country. GVK acquired majority stake in Bangalore International Airport Limited in 2009 and exited in 2017 after transforming it with international standards. Together, these two airports are controlling the majority of the passengers, traffic and cargo business in the country. With this expertise, GVK was also awarded Navi Mumbai International Airport Project in January, 2018 which is being implemented as a subsidiary of MIAL. Under his leadership, "GVK" also awarded the modernization of two projects to develop green field International airports in North Bali and Yogyakarta (Java), Indonesia in the year 2011. During 2011, "GVK" has acquired strategic stake in Thermal Coal and Infrastructure development projects in Queensland, Australia from the Hancock Group for US\$ 1.26 billion. This project has the distinction of being the single largest Foreign Investment by an Indian business group in Australia.

Mr. Ch G Krishna Murthy is a Chartered Accountant and holds a Master's degree in Arts and a LLB Degree. He has been a member, Law Commission of India and has served on the Income Tax Appellate Tribunal in various capacities including President. He has also been a chairman of the Oil Selection Board, Ministry of Petroleum for the states of Karnataka, Andhra Pradesh and Orissa. He was also a practicing chartered accountant.





He was a member of the Governing Council of the International Centre for Alternative Dispute Resolution (ICADR), a member of the General Council of the National Academy of Legal Studies and Research University, a Chairman of the Chinmaya Vidyalaya and a member of the Chinmaya Seva Trust.
